



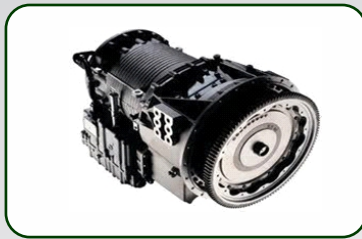

- ◆ Damage from environment including salt, hail, windstorm and lightning.



Income tax rate is 25% Plus 3% AIDS levy giving an effective rate of 25.75% per annum payable in form of quarterly payment dates (QPDs) as follows:

Due dates for annual returns based on actual income statements are notified in the Government Gazette by the Commissioner.

PAYE Employees are required to withhold employees' tax on remuneration exceeding tax free threshold and submit return (form P2) and payments on or before the 10th day of every month after the month of withholding. Employee tax computations are done using tax tables available at Kuruma House, Ground floor, Client Care Reception.

VAT Only registered operators can charge Value Added Tax (VAT). To be registered one must meet the minimum threshold of US \$60000 per annum. VAT payable and the return (form VAT 7) is due on or before the 28th day of every month following the end of the tax period (w.e.f 01/01/2012).

Withholding tax. Every registered taxpayer is obliged to withhold 10% on all payments aggregating to US \$250 or more made under contract to a payee without tax clearance (TF 203). The tax withheld and the return (Rev 5) is due on or before the 10th of the month following that of withholding. Note that there is no need to withhold tax or requesting tax clearance on the following circumstances:

- Payment under contract of employment
- Sale in any shop in ordinary course of business in which case the seller is in business and the buyer is not
- Payment to the state

**NB. A) All payments after the due dates attract penalty and interest at prescribed rates.
B) You are required to submit returns on or before due dates even if you are not trading.**
